Thank you for the information you have provided the Commerce Commission ('the Commission') regarding New Jobz Ltd.

The Commission has assessed the information you have provided, and although the information may raise issues under the Fair Trading Act 1986 ('the Act'), **the Commission will not be taking further action.**

Due to the amount of information the Commission receives under the Act, it is not able to take action in relation to every complaint. This being the case, the Commission has developed a set of screening criteria to assist it in ascertaining those complaints that most warrant further investigation. Among other things the Commission's screening criteria considers the extent of any detriment likely from the conduct alleged, whether the complainant would be better served by taking private action under the Act and whether the Commission is the most appropriate organisation to handle the complaint. It should be noted that the Commission is not able to seek redress for individual consumers. A copy of the Commission's screening criteria is available at:
