Complaint against Unlicensed Immigration Adviser Keith Lightfoot / NewJobZ

Thank you for your complaint dated 16th December 2008, which has been received by the Immigration Advisers Authority.

The Immigration Advisers Licensing Act 2007 (the Act) was brought into place to protect the interests of potential migrants coming to New Zealand and to enhance New Zealand as a migrant destination. The Immigration Advisers Authority (the Authority) regulates the provision of New Zealand immigration advice. From 4th May 2009 anyone based onshore giving immigration advice on New Zealand immigration matters will need to be licensed. Anyone based offshore giving immigration advice on New Zealand immigration matters will need to be licensed from 4th May 2010.

The Authority is only able to investigate complaints about Licensed Immigration Advisers. This means that we cannot investigate the issues you have raised in your letter about Keith Lightfoot / NewJobZ. Please also note that our licences are issued to individual advisers, but not to a company or an organisation.

Once again thank you very much for bringing this matter to our attention. Should you need any further clarifications in regard to our complaint procedure, you may wish to read our complaints brochure on our website at www.iaa.govt.nz, or ring the Immigration Advisers Authority to have a brochure posted to you, or to talk to the Team Leader Investigations.
